Part 1 - MULTIPLE CHOICE:

During the 4th quarter with 2:12 remaining, the score is tied 21-21. A has the ball and faces 3rd and 22 from the 50 yard line. A14 takes the snap and runs to his right and then pitches a backwards pass to A4 who is running three yards behind him. Immediately after throwing the ball, A14 is then hit by B52 and knocked to the ground. After catching the backwards pass, A4 then throws the ball forward towards A18. B17 is covering A18. A18 jumps in the air for the ball and B17 copies him as he has his back turned to the ball and cannot see the ball in flight. As he is reaching for the ball, A18's hand hits B17's face mask and knocks his helmet off. A18 is still able to catch the ball and lands on his feet with possession on B's 33-yard line. A18 begins to advance to continues to advance towards the endzone when B3 dives at his feet and A18 leaps over B3. As he continues to advance, he is hit by B16 on the 26-yard line and fumbles the ball. In a pursuit for the ball, A1 hits B17 who still is helmetless. B17 recovers the ball at the 24-yard line and advances the ball to B's 30 before any official realizes they need to blow the whistle to kill the play.

- 4. K is lined up for a free kick. The kickoff is caught by R22 at his ½ yard line and as he catches the ball, he takes a step backward with the catch, carrying the ball over the end line. Ruling:

After catching the pass, A22 runs down to B's 7 yard line where he is hit by B18 and fumbles the ball forward to B's 5 yard line. B11 scoops up the ball and advances it to his 22 where he is hit by A50 and fumbles the ball. A3 then picks up the ball and runs towards his endzone where he is tackled at B's 18 yard line. After the whistle, B12 shoves A4 in the back. After the penalty enforcement(s) the next live ball will be put in play by A at:

After the interception, B37 pitches the ball backwards to B10 who then proceeds to muff the ball so that it goes out of bounds behind the goal line. - 18. It is 4th and 9 from K's37 yard line. K is lined up in a punt formation. K87 takes the snap from K42 and proceeds to kick the football. The ball lands at K's 33 yard line and rolls to K's 35. K52 then picks up the football and advances the ball to the 50 yard line before being tackled by R31. During the tackle, R31 incidentally grabbed K52's face mask. Ruling:

- 20. On first down at B's 25, A65 commits a false start. B71 then taunts A65 and A52 then uses profanity toward B71. B31 then uses profanity toward A52. By rule, which of the following is true?

After the hit, B17 gets up and is immediately met by several A subs on A's sideline. A's coach steps in to break up the jawing. At the same time A41 and B18 are in a shoving match on the hash marks. The crew flags the incident on the hash marks as players from both A and B's bench leave the sideline. The line judge is positive that A4, A50, A13 and A71 left the bench during the shoving match. After much conversation the rest of the crew is not exactly sure who left the bench for B but is sure that there were 7 players who left. Ruling:
 - A. Offsetting personal fouls on A41 and B18. A4, A50, A13 and A 71 are disgualified.
 - B. Offsetting personal fouls on A41 and B18. A4, A50, A13 and A 71 are disqualified. The crew decides on which 7 B players are disqualified.

- 26. All of the following have special enforcement rules except:

On 3rd down, A12 takes the direct hand to hand snap and pitches the ball backwards to A32 who runs outside the right tackle and is tackled by B52 for a gain of 3 yards. During the run, A82 who is lined up at receiver is flagged for holding B2 while blocking him 2 yards beyond the LOS. After a brief discussion the crew marks off the penalty for holding from B's35, 10 yard penalty repeat 3rd down. The head coach from A is upset at this enforcement and asks to speak with the referee about the ruling. After the discussion between the referee and the Head Coach of team A the following should occur next:

- 29. On 3rd and 8, A20 runs for 6 yards and is hit, losing the ball. During the scramble for the ball, the L is unable to determine who has possession of the loose ball, so he signals to stop the game clock. It is determined that A57 recovered the loose ball 1 yard short of the line to gain. Based on this scenario, the following is true:

Part - 2 TRUE or FALSE

Reminder that TRUE ="A" FALSE = "B"

- 31. Any pass, fumble, kick or muff is considered a loose ball.
- 32. In order to have a simultaneous catch or recovery, both players must be inbounds.
- 33. Team A has the football leading 29-22 with 1:35 on the clock in the 4th quarter. On second down A34 runs for 4 yards and goes out of bounds at the 42 yard line with 1:29 left on the clock. On 3rd and 6, B45 commits an encroachment penalty. **Ruling**: 5 yard penalty making it 3rd and 1 and A has the option to start the clock on the ready for play if the penalty is accepted because the foul occurred inside the last two minutes of the half.
- 34. An illegal formation is the action of one or more offensive players who, after a huddle or after taking their set positions, move to a new set position before the ensuing snap. This carries a 5-yard penalty.
- 35. Prior to the 2nd overtime, the team who lost the coin toss may select to the play the 2nd overtime period at the opposite end of the field from where the first overtime was played.
- 36. If there are multiple issues with the visible play clock and/or the game clock during the game, the clock shall be taken to the field so these issues do not continue.
- 37. 4th and 10 from K's 25 yard line. K1 punts the ball beyond the neutral zone and R20 muffs the ball back behind the neutral zone where K1 recovers and throws a forward pass to K3 which is complete at the 42 yard line. Ruling: Legal play
- 38. K punts the ball towards R's endzone. The ball bounces at the 2 yard line and towards the endzone. K reaches for the ball and has it in his hands at the 1 but is bobbling it. He finally gains possession as he falls into the endzone. Ruling: It will be a touchback, R's ball at the 20.
- 39. It is the 2nd Quarter with 6:22 remaining. On 2nd and 8 from A's 32 yard line, A8 runs outside the tackle where he is hit by B45. A8 spins off the hit on B45 and continues to run downfield. After the hit, B45's artificial left arm dislodges and falls off. The Referee notices the limb has come off and blows his whistle to stop the play. At the time the whistle is blown, A8 is on his 39 yard line with no one between him and the endzone. Ruling: Ball is dead at the A's 39 due to the prosthetic limb coming off.
- 40. A pass thrown backwards out of bounds to stop the clock is an illegal pass.
- 41. There is no limit on the number of personal fouls a player can commit.
- 42. A free kick shall be made from any point on K's free kick line.
- 43. The ball has been marked ready for play and team A is at the line of scrimmage. The snapper gets over the ball but does not touch it as signals for the play are sent in from the sideline. While this is going on, B78 lines up with his head in the neutral zone. Ruling: Encroachment on B78.

- 44. During the post- game handshake as the officials are moving off the field the back judge notices A13 slug B29. The back judge is to throw a flag signifying a penalty for unsportsmanlike conduct so the coaches know that there is a penalty for which A13 will be ejected.
- 45. The enforcement spot for any foul by the defense is the goal line when the run ends in the end zone and would result in a safety.
- 46. A drop kick may be used on a kickoff.
- 47. On 4th and 12 from K's 40 yard line, K81 punts the football. During the kick, R33 if flagged for a hold at the 50 yard line. R22 catches the punt at his own 33 yard line and immediately retreats to avoid being tackled. After running around and changing directions several times, R33 is eventually tackled on his own 19 yard line. Ruling: K can either decline the penalty and it will be R's ball at the 19 or accept the penalty and it will be R's ball at their own 9 yard line.
- 48. B's coach is visibly upset during the first half of the game claiming that his headsets are not working and that the home team has something to do with this. Early in the 3rd quarter the R notices the head coach using his iphone 7 to communicate with his coordinator in the press box. Ruling: Legal use of electronic equipment:
- 49. K is lined up in a scrimmage kick formation to punt the ball. K13 punts the ball from the 50. R5 muffs the punt on the 2 yard line and the ball bounces into the endzone and is recovered by K34. Ruling: Touchdown.
- 50. Touching of a scrimmage kick is always ignored if the touching occurs in or behind the neutral zone.
- 51. There can never be a situation where the line to gain is not the goal line during overtime.
- 52. After scoring a touchdown, A14 requests the ball be placed on the right hash for the try before the ready for play. At the line of scrimmage A14 looks at the defensive formation and then requests a timeout. During the time out, A14 asks for the ball to be moved to the left hash for the try. Ruling: This is allowed as captain has choice on where to place the ball.
- 53. During a scrimmage kick snapper K52 runs three yards downfield after snapping the ball. R34 then proceeds to hit K52 knocking him to the ground. Ruling: Roughing the snapper.
- 54. A scrimmage formation requires 5 A players behind the line of scrimmage at the snap.
- 55. If both coaches agree, it is acceptable to hold the coin toss off the field.
- 56. A11 takes the snap and is immediately under pressure. He scrambles to his right, then reverses field to scramble to his left and sees A82 blocking B40 10 yards downfield and A14 breaking away from B33 two yards downfield. A11 throws and completes the pass to A14 for a five yard gain. Ruling: Pass Interference on A82
- 57. If a double foul occurs during a down in which time expires, the period is ended.

- 58. On 2nd and 5 from the A30 yard line, A2 hands the ball to A41. A41 is hit by B17 at the 27 yard line by B33 but is not stopped. B21 then runs up and without breaking his stride and with no struggle takes the ball from A41 and continues running. B21 runs to A's 3 yard line and is tackled. A is flagged for holding before the change of possession at A's 32 yard line. If B accepts the penalty, it is enforced from the A's 3 yard line and is B's ball.
- 59. Only one receiver may give a signal for a fair catch while any legal kick is in flight.
- 60. On a Free Kick that follows a fair catch, the crew shall position themselves exactly as they would for a scrimmage kick (field goal attempt)
- 61. Roughing the passer can only occur on and legal forward pass. You can never have roughing the passer on a backwards pass.
- 62. Due to injury, K71 is now the holder for the extra point. By rule he is ineligible to throw a forward pass.
- 63. Any K player may catch or recover any scrimmage kick while it is in or behind the neutral zone and advance it.
- 64. After a safety, unless moved by a penalty, R's free kick line is K's 30 yard line.
- 65. Any receiver can always catch or recover a free kick in the field of play.
- 66. If the ball is beyond the neutral zone when it leaves the passer's hand on a forward pass, it is an illegal forward pass.
- 67. The difference between an illegal fair catch signal and an invalid fair catch signal is that an invalid fair catch signal occurs after the kick has either been caught or recovered.
- 68. All unsportsmanlike fouls are non-contact fouls.
- 69. A kick ends once any player secures possession.
- 70. A player will be disqualified for refusing to comply with a game official's directive.
- 71. A54 lines up behind the line of scrimmage prior to the snap. Once the ball is snapped, he cannot go downfield on a legal forward pass.
- 72. All fouls by A during the down are enforced from the basic spot.
- 73. At the end of each quarter the team of officials shall all come together to discuss what down, distance and yard line the ball will next be placed as well as handle any other communication issues the group needs to discuss unless they are using headsets at which point no meeting is needed.
- 74. While lined up for a free kick, K must have at least four players on each side of the kicker.

- 75. A forward pass has gone beyond the neutral zone if at any time during the pass, any part of the ball is beyond neutral zone.
- 76. The referee has the authority to correct an error in the number of a down until a new series is awarded.
- 77. It is always a touchdown for A when a live ball in A's player possession breaks the vertical plane of B's Goal line.
- 78. The U arrives at 6:01 for a 7:30 kick. Although he is not there at 6:00, he is not considered late because the crew has not yet started its pre-game meeting.
- 79. A51 is pass blocking B60 behind the line of scrimmage. B42 blitzes from his linebacker position 4 yards behind the line of scrimmage. A51 notices B42, leaves his block on B60 and blocks B42 below the waist prior to B42 getting to the QB. Ruling: legal block.
- 80. Clipping in the free-blocking zone is illegal.
- 81. The dead ball signal, incomplete pass signal and time-out signal are all signals to signify starting the 40 second clock.
- 82. A 71 is the lead blocker on a sweep play. While getting outside the tackle to lead the block, B31 blocks him below the waist. Ruling: Penalty, blocking below the waist on B31.
- 83. 1st and 5 from A's 31 yard line. A 12 takes the direct snap 4 yards in the backfield and runs to his left. During the run, B72 is being blocked by A51 and A12 trips over B72's foot while trying to get outside. Ruling: Tripping the runner 10 yard penalty.
- 84. The following is a legal scrimmage formation:

- 85. During a 2nd down run, A24 breaks off tackle and appears to be headed for score. B9 comes from behind and grabs A24s nameplate area on his left shoulder and subsequently pulls him backwards to the ground at B's 30 yard line. Ruling: Legal tackle, 1st and 10 from the 30.
- 86. A has possession of the ball at their own 45 yard line facing 3rd and 4. At the exact moment the ball is snapped, B36 realizes they have 10 men on the field and runs on the field from the sideline and participates in the remainder of the play which results in A5 gaining 5 yards on a run. Ruling: Illegal participation, 15 yard penalty, A's ball 1st and 10 at B's 35 yard line.

87. The following is a legal scrimmage kick formation on 4th down:

- 88. During overtime A wins the toss and elects to go on defense first. B chooses to play at the north end of the field. Both teams fail to score on their possessions. From this point forward, there is no coin toss needed and B will have choice of the options. If additional overtimes are needed you will continue to alternate the choice of options without the need of a coin toss.
- 89. In the case of a double foul, the captains are not consulted as the penalties will offset.
- 90. A helmet can be any color regardless of who is the home team.
- 91. During the first overtime, A11 is hit by B62 prior to throwing a forward pass. A11 fumbles the ball and B9 scoops up the fumble and scores. Ruling: touchdown, no PAT needed as the game is now over.
- 92. It is a touchback if A1 fumbles on B's 5-yard line and B1's muff forces the loose ball into B's end zone and out of bounds beyond the end line.
- 93. After a safety, K1 kicks from K's 20. R1 standing at his own 40 muffs the kick out of bounds at R's 45. Ruling: The only option that R has is to put the ball in play at R's 45.
- 94. From B's 20 yard line, A lines up in a field goal formation on 4th and 3. Once the ball is snapped, A17 who is lined up one yard in the backfield circles in front of the holder who without leaving his initial position tosses the ball forward to A17 who then runs around the left end for a 15 yard gain. Ruling: Illegal forward pass.
- 95. On first and 10 at A's 40, A12 throws a short pass that is dropped by A8 near the left sideline. A8 returns up the sideline to line up without ever returning inside the 9 yard mark. At this point, the wing official should use preventative officiating and tell A8 that he needs to be inside the 9 yard mark after the ball is ready for play at least momentarily.
- 96. A forward pass thrown from beyond the LOS is the primary responsibility of the L or LJ.
- 97. For a normal free kick, all officials should carry the bean bag in their hands.
- 98. If a player has been disqualified, the offending player shall be notified and the calling official shall report his number and infraction to the coach and all other members of the crew. It should be emphasized to the coach that the player is disqualified for the remainder of the game.
- 99. Following a first down, the ball is spotted, and the down box indicator and chains are not set. The Umpire shall stand over the ball until they are both set.
- 100. During the pregame conference, the BJ and L talk and determine that with the style of play both teams use they need to switch positions to better officiate the game. This is acceptable provided the R agrees to allow them to do so.
