1. Call to Order—Gary Lukridge

2. Finance Committee- Garrick Messer

- Present Recommendation for Treasurer for SCFOA
- Finance Committee Met on February 25<sup>th</sup>.
- Tax Returns completed by John Price on March 2<sup>nd</sup>, 2024.
- Fiscal Year for SCFOA runs from March 1-February 28<sup>th</sup>.
- Recommendation for Treasurer to Watch SCFOA Finances/provide a year end statement.
- At current we do not have an updated financial statement.
- Takes 3-4 Months for checks to be deposited and cleared.

- Treasurer would be Non-Voting Board Member
- Recommended 3-year Term because of continuity.
- Treasurer to provide Annual Financial Report to Membership.
- Recommend sending this to the Governance Committee to formulate a Constitutional Amendment to be voted on by Membership during the July Meeting.
- Position would begin January 1, 2025.

#### Discussion:

- Darryl Jackson: What are qualifications.
- Gary Lukridge: Accounting degree? Financial Background? These items would need to be clarified with the Governance Committee, but we do not want to make this too strict when we need to fill the position.
- Darryl Jackson: Who can sign the checks 1- or 2-person signature.
- Chip Dickert: 1 signature/ Multiple can sign when necessary.
- Chip Dickert: In his opinion this could be done by the Board in Bylaws. Does not need to go to membership.
- Keith Hajnal: Requested Clarification if SCHSL would allow us to take over our finances.
- Darryl Jackson: Is treasurer required to attend Board Meetings. Will we pay for travel?
- Garrick Messer: Non-Voting Member, Not required to attend meetings call in via Video, when necessary, will provide annual and quarterly financial information to SCFOA Board.
- Todd Johnson: Duties of Treasurer/Position is past due/Recommended for transparency this be voted on by Membership.

- Brad Smith: Transparency is key for our membership.
  - Bryant Williams: Position would be beneficial to SCFOA.
  - Greg Hawkins: Had question on if non-voting why go to membership?
  - Chip Dickert-3-year term for stability.
  - Darryl Jackson: What happens with impropriety who replaces the position?
  - Brad Smith: Put morality clause in job description. Can be removed from board “for cause”.
